When you contact us

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored so that it is possible to contact you and respond to your correspondence, provide information, if appropriate to other principal authorities (eg government agencies) to enable Marston Parish Council to answer your queries, and/or access our facilities and services. Your personal information will be not shared or provided to any other third party.

The Councils Right to Process Information

General Data Protection Regulation (GDPR) (Data Protection Act 2018) Article 6 (1) (a) (b) and (e)

Processing is with consent of the data subject

or

Processing is necessary for compliance with a legal obligation or

Processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller

Information Security

Marston Parish Council is aware of the need to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and appropriate policies.

We will only keep your data for the purpose it was collected for and only for as long as is necessary, after which it will be deleted.

Children

We will not process any data relating to a child (under 13) without the express parental/guardian consent of the child concerned.

Your Rights

Access to Information

You have the right to request access to the information we have on you. You can do this by contacting our Data Protection Officer: clerk@marstonparishcouncil.org.uk.

Information Correction

If you believe that the information we have about you is in incorrect, you may contact us so that we can update it and keep your data accurate. Please contact: clerk@marstonparishcouncil.org.uk.

Information Deletion

Right to Object

If you believe that your data is not being processed for the purpose it has been collected for, you may object: Please contact clerk@marstonparishcouncil.org.uk.

Rights Related to Automated Decision Making and Profiling Marston Parish Council does not use automated decision making or profiling of individual personal data.

In Conclusion

In accordance with the law, we only collect a limited amount of information about you that is necessary for correspondence, our information and service provision. We do not use profiling, we do not sell or pass your data to third parties. We do not use your data for purposes other than those specified. We make sure your data is stored securely. We delete all information deemed to be no longer necessary. We constantly review our Privacy and GDPR Policies to keep them up to date in protecting your data.
